- County Boards that pass the tax levy for the first time shall be entitled to receive a free MACDDS membership *for the year of passage and the following year only*. Counties applying for membership for the first time pay the full amount of dues if the tax levy was passed more than a year prior to date of application for membership.
- A County Board, not previously a MACDDS member at any time in the past, joining on or after September 1, shall pay dues equal to one-third of the amount of the annual dues. The dues amount is not otherwise prorated, regardless of date of application.
